 4 The figures for the corresponding previous periods have been restated/regrouped, wherever necessary, to make them comparable.

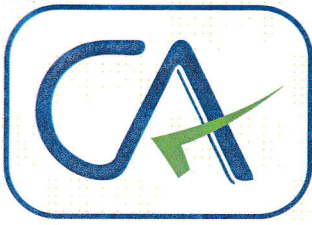
